The following board members are 5 here: Mr. Callahan, Ms. Sheidt, Mr. Trotta, Mr. Braun, and also joining the meeting via Zoom, 6 7 Mr. Grucci and Mr. Pollakusky. 8 (Inaudible) 9 MS. Today's meeting has been convened in 11 accordance with Chapter 56 of the laws of 2022, effective April 9th, 2022 permitting local 12 13 governments to hold public meetings by telephone 14 and videoconference. And just to take it a little bit 15 further, Governor Hochul has extended the state 16 disaster emergency set forth in Executive Order 17 18 11, which continues the suspension and 19 modification of the laws contained in Executive 20 Order 11 and its successors through September 12th 21 and that includes open meetings laws. 22 MR. BRAUN: Minutes of our meeting 23 of September 15th of 2021 in the -- do I have a 24 motion to accept? 25 MS. SCHEIDT: So moved.

1 mention to the Finance Committee is the budget. We're starting the process of the 2023 budget. 2 It's a combination of both a zero-based 3 4 budget, meaning it starts with nothing, and works 5 up. And I also look at prior years and periods. б The budget's due to the ABO by October 31st, so 7 we're in line to meet that deadline. The other thing I want to mention is 8 9 our banking arrangements. Rates have continually 10 crept up. And we're starting to get a little bit 11 more on our accounts. I mean, we're not at a full 1 percent yet, but we're closer and closer every 12 13 day. Today, we got another notification from one 14 of our banks, saying they're up to .9 percent. So we're almost at that 1 percent. So I just want to 15 16 mention that. 17 Any questions? 18 MS. SCHEIDT: (Inaudible). 19 MR. BRAUN: Anything else, Lori? 20 MS. LaPONTE: Nope. Not for the 21 LDC meeting. 22 MR. BRAUN: Awesome. Lisa? 23 Anything else? (Pause.) No? 24 MS. MULLIGAN: No. I don't have 25 anything for the Finance Committee. Thank you.
